ANALYSIS OF TRAINING SESSION ON PROJECT WRITING AND MANAGEMENT GAMCON YOUTH LEADERSHIP PROGRAM

GaMCon Youth Leadership Program focused on the strengthening the capacity of the youth in the areas of civic activism and project management in order to provide them with the appropriate tools to become the actor of their own future and a source of change for their community. Through the 2-days training we provide participants with theoretical knowledge about project writing and management, inspire them with very concrete examples to complete the project proposals and the budget.

This training was therefore an essential step in order to give them an understanding of what is the responsibility, accountability, to get them interested in establishing their own initiatives and provide them with the appropriate tools to achieve the project proposals.

As part of the training, the participants gained knowledge and an interesting and interactive insight in the following areas:

- Responsibility between the donor and the final beneficiary of the GAMCON Project.
- Financial rules and procedures of Moldova that apply to use of financial resources.
- Transparency and accountability of the final beneficiary of the GAMCON Project.
- Guidelines for the development of a narrative and financial reports of the final beneficiary of the GAMCON Project.
- Discussion and analysis of the developed project proposals.
- Key aspects of successful project and motivating NGO achievements in the Republic of Moldova.

Training methodology

During the training used different tools of working with the audience: Brainstorming, Power Point presentation, group and individual work of the training participants,

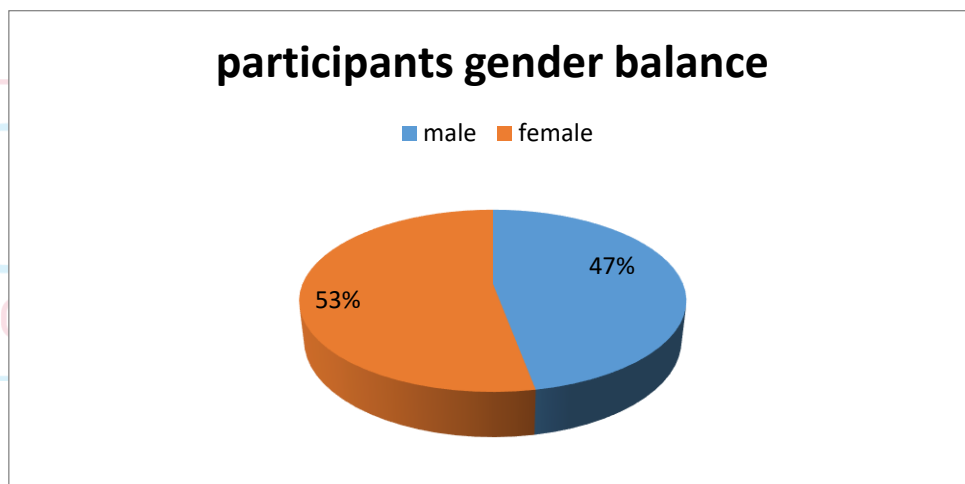

The training was practical, the participants were receive information and practical skills as a beneficiary of the GAMCON Project (tools for transparency, accountability and transparency, development of an accountable and financial report at all stages of the project implementation, analysis of all risks in the development and implementation of the project). Training participants

17 young active people from Gagauzia took part in the training. The participants of the training are aimed at positive changes in their communities through the writing of projects in Gamcon.
