



- 1) Program **Support of Youth NGOs** - national wide youth NGO's;
- 2) Program **Services for young people** – volunteering and information and counselling services for youth;
- 3) Program **Voice of young** – regional and national umbrella organizations responsible for advocacy youth issues;
- 4) Program **Priorities of youth policy** - innovative and experimental projects focused on the new quality systems in youth work;
- 5) Program **Evidence of youth** – youth research



Implementation of the Strategy should be governed **by the project principle** – with measurable indicators in order to achieve **easier deduction and monitoring of the process!**

Members are: Youth Department of the Ministry of Education, representatives of Iuventia – administrator of the grant scheme and representatives of the organization that received the grant
