## **Working Group «Social Infrastructure»**

Main result of the three sessions of the Working Group “Social Infrastructure” was detailed analysis of the current situation in the ATU Gagauzia in the field of social infrastructure made by local expert Anna Nyagova. The social problems of the modern family were analyzed, a draft plan of measures to strengthen the young family was reviewed, and parenting skills were discussed under the general title of the “Educating Effectively” program.

The main goal of the final, fourth session of the WG “Social Infrastructure” is to present and discuss the final version of the program document “Strategy of Young Family Support for ATU Gagauzia”.

The document was developed by a Gagauzian and Slovak expert and is based on the suggestions and proposals of the participants of the previous session.

During the final session, foreign experience in the implementation of strategic documents will be presented, as well as monitoring and interaction with the public sector.
